

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to customers, and Ewe and Me Farms and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Ewe and Me Farms include <https://www.eweandmefarms.com/> and Ewe & Me Farms. The Ewe & Me Farms application is a sales application. By using the Ewe & Me Farms application, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Ewe & Me Farms may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Ewe & Me Farms's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Ewe & Me Farms may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ## Sharing Information with Third Parties

Ewe & Me Farms does not sell, rent or lease its customer lists to third parties.

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Ewe & Me Farms collects personally identifiable information from children under the age of thirteen. Ewe & Me Farms collects this information for the following reason(s): Field trips and volunteering.
